Nuello® iN contains living microbes, ensure good practice to achieve desired benefits:

- ✓ Add newly opened microbes to prepared Extender
- ✓ Use within 24 hours of mixing
- ✓ Shake well until dissolved prior to applying as a seed treatment
- ✓ Water volume: Minimum of 4 litres of water per tonne of seed to ensure adequate coverage
- ✓ Water pH: 5.5 – 8.5
- ✓ If co-applying with other seed treatments, avoid tank mixing.
- ✓ Store treated seed in a dry place correctly labelled
- ✓ Drill as recommended
- ✓ Only use unopened sachets
