

SYNGENTA PULSE EVENT SURVEY COMPETITION RULES

By entering the Competition, you (the "Entrant") accept and agree to comply with these Rules. In all cases our decision is final and no correspondence will be entered into.

1. Eligibility Requirements

1.1 The Competition is open to residents of the UK only, excluding employees of Syngenta and their immediate families and anyone else professionally connected with this Competition.

1.2 Entrants must be 18 years old or over and we reserve the right to request proof of age from any potential prize winners.

1.3 Multiple entries are not permitted.

2.1 The Competition begins on 22/02/24 and closes at 23:59 on 08/03/24 ("Competition Period"). All entries must be received before the expiry of the Competition Period.

2.2 All valid Entries received during the Competition Period will be entered into the Competition. The Competition will be judged, and winners decided on 12/03/24. Our decision concerning all matters relating to the Competition, including the determination of the winner(s), will be final and binding.

3. How to Enter

3.1 **No fee or purchase necessary.** To enter, Entrants must fill in the Pulse Event survey. The first 25 entries received will be selected for the prize. Winner(s) will need to provide their email address so that we can contact the winner(s).

3.2 No other forms of entry will be accepted.

3.3 We accept no liability for lost, late or misdirected entries, for technical failures of any kind or for any human error which may occur in the receipt or processing of the entries.
