4.1 Description of first aid measures

4.2 Most important symptoms and effects, both acute and delayed

Symptoms : Aspiration may cause pulmonary oedema and pneumonitis. Skin contact paresthesia effects (itching, tingling, burning or numbness) are transient, lasting up to 24 hours.
